

What is program?

League program is the education and advocacy platform that we adopt to move our mission forward.

What is program planning?

- Program planning is the grassroots process of recommending and selecting governmental issues for study and agreement in reaching a position.
- Program is based on Member Understanding and Agreement.

Article XII of the LWVUS Bylaws outline the process

Sec. 1. Principles. The Principles are concepts of government supported by the League and are the authorization for adoption of national, state and local program. They may be amended by the convention in the same way as program is adopted under Section 2 of this Article.

Sec. 2. Program. The program shall consist of action to implement the Principles and those governmental issues chosen by the convention for concerted study or concurrence and action.

Program Bylaw (Continued)

A. Local and state League and ILO boards shall make any program recommendations to the national board by a date, set by the board, that is at least three months prior to the convention.

B. The national board shall consider these recommendations and formulate a proposed program which shall be sent to the presidents of local and state Leagues and ILOs at least six weeks prior to the convention.

Program Bylaw (Continued)

C. Any League that plans to propose the adoption or amendment of a national League position by concurrence with a position statement of another League or Leagues shall submit the recommendation to the national board as specified in Section 2A of this Article. Any League, or the national board, that plans to propose the adoption or amendment of a national League position by concurrence with a position statement of another League or Leagues on the floor of convention shall send the proposed position statement, background information, including pros and cons on the issue and an explanation of the rationale for using this form of member agreement, to all Leagues at least six weeks before convention.

Program Bylaw (Continued)

D. The convention shall adopt a program by a majority vote on each subject presented to it. A program recommendation submitted by a local or state League or ILO by the date set by the national board as specified in Section 2A of this Article but not proposed by the national board may be adopted only if its consideration is ordered by majority vote of the convention and the vote on adoption comes on a following day. A two-thirds vote is required to amend or adopt a national League position by concurrence on the floor of convention.

Study



- Developing consensus and member agreement in broad terms on what they think about various aspects of the policy issue.



Concurrence

Any League that plans to propose the adoption or amendment of a national League position by concurrence with a position statement of another League or Leagues shall submit the recommendation to the national board as specified in Section 2A of this Article. Any League, or the national board, that plans to propose the adoption or amendment of a national League position by concurrence with a position statement of another League or Leagues on the floor of convention shall send the proposed position statement, background information, including pros and cons on the issue and an explanation of the rationale for using this form of member agreement, to all Leagues at least six weeks before convention.

Leagues submitting concurrences should follow the procedure set forth by the Program Planning Committee. All concurrences related to the 2022 Convention will be posted here.

The messages section is only to be used by League members to ask clarifying questions of the concurrence posters. It is NOT for general Convention discussion or to debate the concurrences or other Convention business. For this reason all messages will be moderated by LWVUS staff.

- Assume positive intent of all participants.
- Our nonpartisan and DEI policies apply to this space.
- If you see a message that you believe is inappropriate please contact the group facilitator with a link to the message.
- Please do not start a new topic but include your message under one of the existing topics.
- All messages are moderated. Please do not resubmit a message unless it has been 48 hours since you submitted it and no action has been taken on it. All messages will be reviewed and either posted to the message or kept moderated while a member of staff discusses the message with the sender.





Incorporate DEI

- A DEI lens is a way of examining the process as to how it is perceived by a variety of communities, voices, and perspectives, and what, if any, barriers may exist that prevent it from being equitable or inclusive of everyone.



Program at Convention

- Board-recommended 2022-2024 program (sent to Leagues six weeks before convention).
- Not recommended program items granted motion to consider.
- Concurrences granted motion to consider.
- Resolutions expressing the will of the convention body on issues.
